Assalamu Alaikum Warahmatullahi Wabarakatuh

At the outset, let me welcome you all to the Headquarters of the Organization of Islamic Cooperation as well as to Jeddah, the gateway to the two most holy places for the Muslim Ummah. I thank you all to be able to make time to join us for the OIC-CERT Annual Conference 2016 under a very pertinent theme "Towards Cyber Resilient Ummah".

The OIC-CERT draws its mandate as well as strength from the OIC resolution on "Collaboration of Computer Emergency Response Team (CERT) among the OIC member Countries adopted in Kampala, Uganda by the 35th OIC Council of Foreign Ministers in June 2008.
